Appendix A

All terms are as defined in the National Animal Identification and Tracing Act 2012 ("the Act").

- (1) I am registered as a PICA or PICA delegate with the NAIT organisation.
- (2) I appoint Livestock improvement Corporation Limited ("LIC") as my information provider to perform on my behalf one or more of the functions or duties of me, as a PICA or PICA delegate, including animal registrations, providing animal movement declarations, providing information to the NAIT organisation and providing notification when NAIT animals die or are exported live.
- (3) I warrant that all information I provide to LIC, for LIC to provide to NAIT will be accurate, up to date, timely and complete.
- (4) I confirm that I am the owner or lessee or I am otherwise authorised by the owner or lessee to register as the PICA or PICA delegate for all the NAIT animals I have identified at the NAIT location I have specified to LIC.
- (5) I authorise LIC to obtain the information to be provided to NAIT regarding the NAIT animals I have identified at the NAIT location I have specified to LIC, from the information that is recorded in LIC's database, through LIC's MINDA service, and I confirm that such information is, and will continuously be, accurate, up to date, timely and complete and will be provided by the PICA, or a PICA delegate.
- (6) I understand and agree to comply with all of my statutory NAIT obligations and regulatory requirements.
- (7) I authorise LIC to provide all required information, including personal information, to the NAIT organisation to enable LIC to perform its duties as an information provider.
- (8) I acknowledge that I remain responsible for compliance with the Act, in respect of all the PICA or PICA delegate duties and responsibilities, and I agree that LIC shall not be liable to me or any third party for any breach of my statutory NAIT obligations and regulatory requirements.
